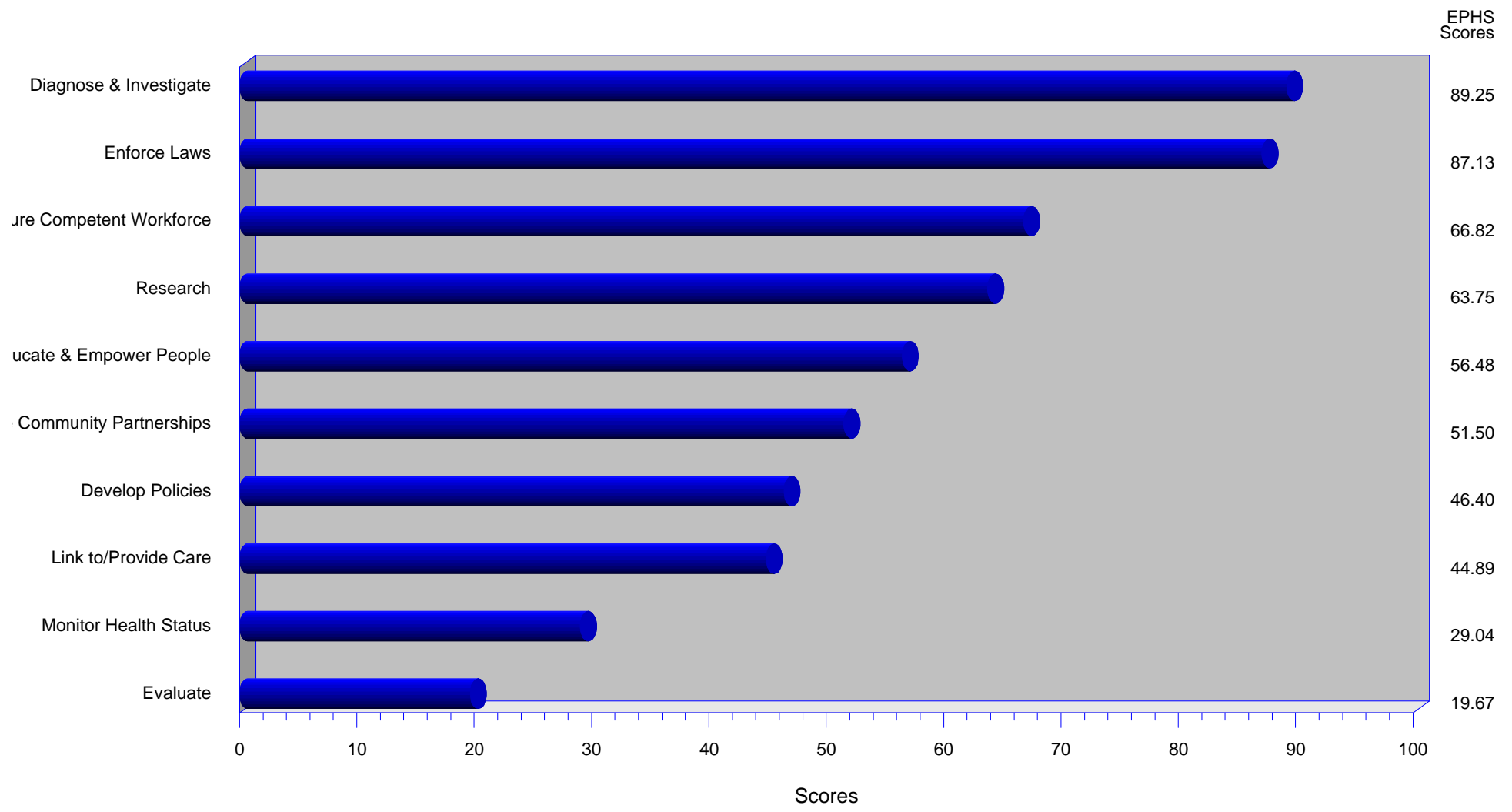

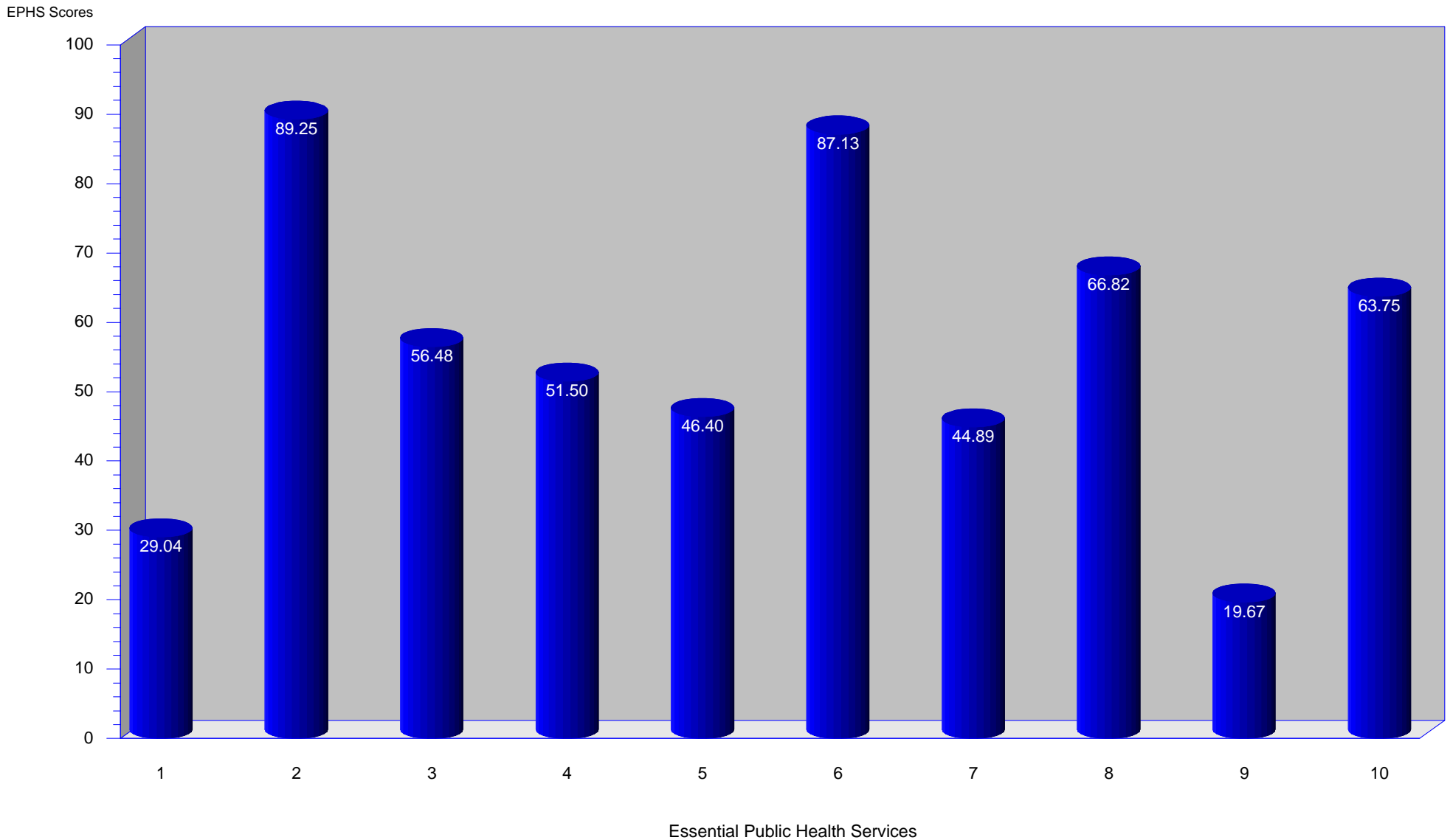

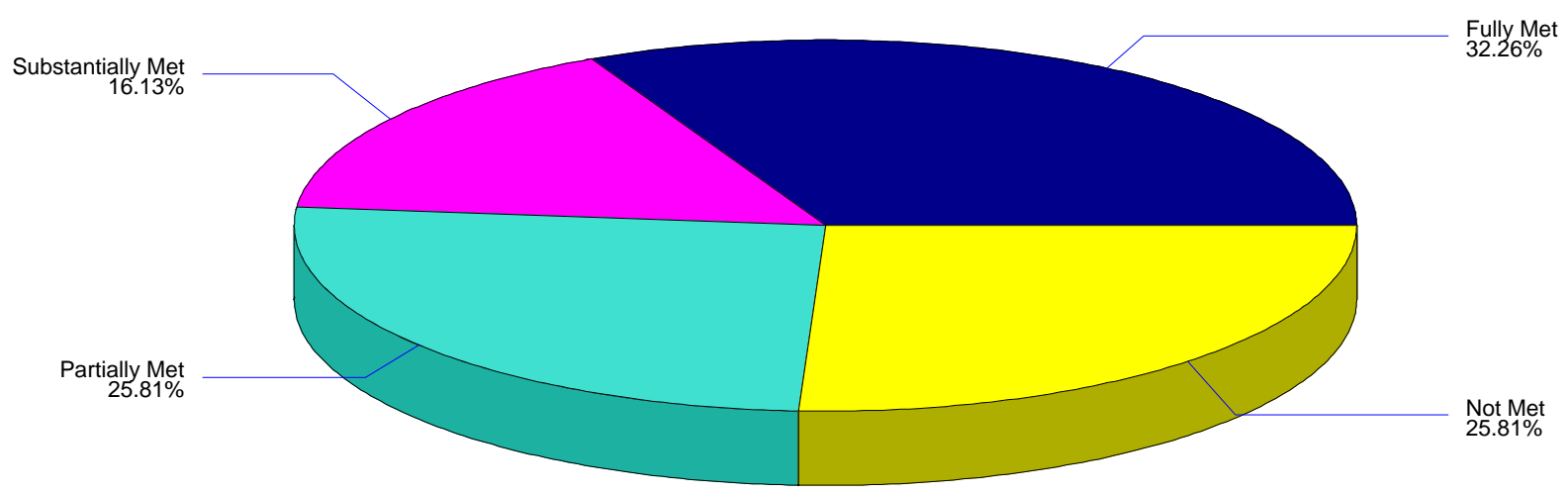
How Did We Perform In The Ten Areas Of Essential Public Health Services (EPHS)?

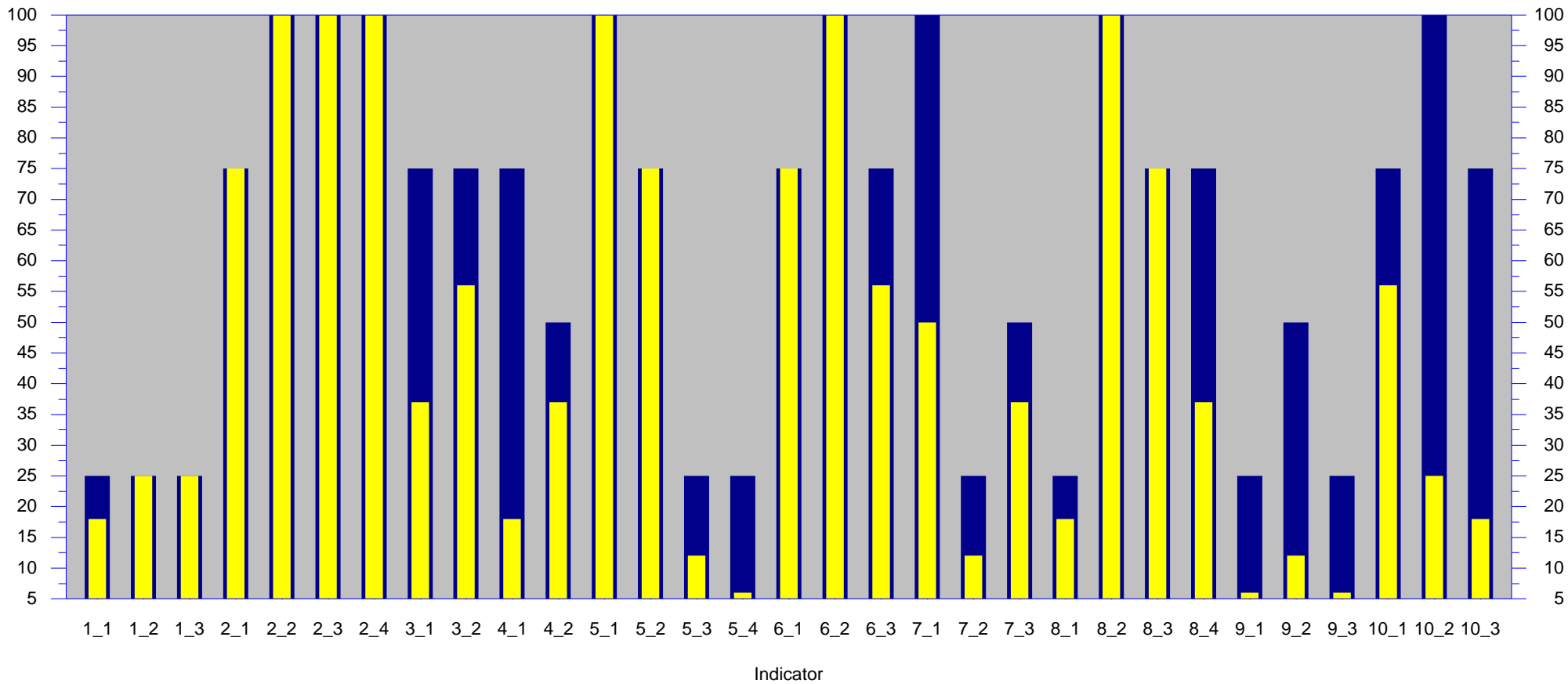
